CALL TO ORDER: President Tara Kuipers called the regular meeting of the Northwest College

Board of Trustees to order on Monday, April 8, 2024, at 4:02 p.m. in the

Yellowstone Building.

A APPROVE THE AGENDA: A motion was made by Trustee Laursen and seconded by Trustee Kost to

approve the agenda. Motion carried.

MISSION MOMENT Shelby Wetzel shared that Northwest College's fourth annual Giving Day was the most successful, raising \$175,735 from 378 donors during the twenty-four-

hour period. The total raised was \$38,000 more than last year, with a thirteen percent increase in donors. The Foundation is extremely grateful for the challenge donors who provided gifts to inspire giving and jumpstart

participation.

This year, the Foundation utilized a new platform, Give Campus, which provided a more sophisticated tracking process and the opportunity to populate real-time numbers. This allowed people to see the success of the different academic program initiatives.

Shelby stated that the Foundation develops different strategies for Giving Day each year to help drive numbers and activity. With this being the last year of fundraising for the Student Center, the Foundation focused on an all-in promotion for faculty and staff and also rallied retirees to participate. Another strategy to drive giving was the Legacy Wall, where donors had naming opportunities in the study center rooms.

Jill Hartmann, Alumni and Development Coordinator, explained that the "All-In" campaign was an appeal for 100% of current faculty and staff to make a gift to the Student Center. The goal was to offer an opportunity for employees to be unified in their support of the new building and to be proud when the building opened that everyone helped to make it happen.

The campaign was supported by alum Clay Cummins, who offered to match all employee gifts to the Student Center, which meant that employees could have their names added to the Legacy Wall for half the cost. President Watson also incentivized giving by offering each constituency group a reward if 100% of their group participated. Faculty were to receive doubled professional development funds for FY2025 and free lunch in the Dining Hall. The reward for Professional Staff and Classified Staff was a half-day of vacation. Both Professional Staff and Classified Staff reached the goal of 100% giving.

Jill stated that in addition to the All-In initiative, retiree Charlotte Patrick challenged retirees. She offered a 100% match of gifts made to the Student Center, which meant that retirees could also have their names included on the

Legacy Wall for half price. Fifteen retirees took advantage of Charlotte's match; over \$2000 was raised from those gifts.

Cory Ostermiller, Development Manager, stated that the Legacy Wall was an opportunity for donors to leave their mark on the Student Center. Those who participated will have their name permanently attached to the glass on the study room walls. Nearly 200 Giving Day donors participated in the initiative. Different giving levels dictated the size of a person's name on the Legacy Wall. Cory stated it was very successful and heartwarming throughout the day to have alums come in and give in honor of family members who had passed away or for young children who will hopefully become future Trappers. Cory stated that while it was a significant initiative on Giving Day, donors still have the opportunity to leave their mark on the Legacy Wall by visiting the website or contacting the Foundation directly.

Shelby stated that department projects were introduced the previous year as a way for alums to give back to an area of their greatest passion and help students who are following in their footsteps. Seventeen programs joined the initiative this year, and approximately \$25,000 was raised for the various projects. Five of the projects met their goals, and the Foundation is working on plans or possible grants to accomplish the goals of outstanding program areas.

Shelby shared that the Ag department hoped to raise \$2000 for a new drone project. They received the first gift of Giving Day, \$1000, and raised \$4800 in total. It was very exciting to see, and the Foundation wants to continue to have academic projects because people feel good helping provide students with future opportunities.

Shelby stated that the Foundation will soon begin planning for the next Giving Day. They are very grateful to all who supported the event and appreciate the opportunity to present its success to the Trustees.

A motion was made by Trustee Laursen and seconded by Trustee Todd to approve the consent agenda.

Trustee Housel recognized the Wrestling team's success at the National NJCAA Tournament, those who placed, and Aziz Fayzullaev, who won his second national championship.

In response to a question from Trustee Housel, President Watson stated that the Regional Needs Assessment research report is considered in draft form and is being reviewed for accuracy. For instance, the assessment states that Northwest College should consider adding an LPN program. The College had a standalone LPN program but recently consolidated it into a stacked credential model. Once the report is finalized, it will be shared with Trustees and the campus community.

Trustee Housel expressed his appreciation for Bob Becker and the two students who traveled with him to Cheyenne to judge and recruit high school students at the Wyoming State Speech and Debate Tournament.

Trustee Housel congratulated Dr. Greg Smith for being awarded a 2024 Wyoming NASA Space Grant for his proposal *CSI Powell: Developing an Upper Division Forensic Anthropology Course at Northwest College.*

In response to a question from Trustee Housel, President Watson stated that the new Forensic Anthropology course will be taught as part of the Criminal Justice BAS program, and the grant awarded to Dr. Smith is for equipment for the course.

In response to a question from Trustee Housel, President Watson stated that there have been many discussions about partnering with the Buffalo Bill Center of the West and finding projects that serve both. Keith McCallister has been collaborating with them on a river raft trip as part of the Outdoor Education program. These collaborative experiences with the Museum could build excitement and, in turn, enrollment.

Trustee Housel noted the popularity and appreciation for the Senior Citizen's program at Johnson Fitness Center. He feels that the more community members are engaged in campus activities, the more they will be invested in the College.

In response to a question from Trustee Housel, President Watson explained that the Rocketbooks TRiO students use for note-taking are notebooks that allow the user to save the written content digitally.

Trustee Housel recognized and expressed his appreciation to the faculty leading the effort to bring recycling back to campus.

In response to a question from Trustee Housel, President Watson stated that the Personnel Status Report indicates more open positions than usual as the College is working to convert interim positions on campus to permanent ones. Additionally, some failed searches are now open until filled, so they continue to appear on the report, as do open positions due to retirements.

In response to a question from Trustee Housel, President Watson stated that the national average for the drop in occupancy levels in residence halls from fall to spring semesters due to natural attrition is 12-15%. Northwest College commonly experiences rates within that range. The Fall 2023 to Spring 2024 drop was approximately 15%.

Trustee Laursen noted that the number of students GEAR UP serves indicates that the College meets students' needs.

Trustee Laursen attended Career Day and felt it was an excellent event for students and community members.

In response to a question from Trustee Laursen, Carey Miller explained that the Niche data included in her advertising report reflects February, which is generally a light month for inquiries. Niche is a college search website where prospective students can create a login and search all schools. President Watson explained that Niche is the most commonly used search tool by high school students. While every college has a presence on Niche, having a paid partnership with Niche allows Northwest College to be highlighted and have more control over the information on its Niche profile.

President Watson stated that the College mailed 23,000 postcards, placed social media, and paid advertisements in the newspaper inviting community members to complete the Community Needs survey. It is open until April 30, and everyone is encouraged to participate.

Trustee Housel stated that he appreciates the CDL reports regarding enrollment and completion. He would like to see a similar annual report regarding the Aviation program. President Watson noted that there is a report showing enrollment in all credit programs that can be shared with the Trustees.

Motion carried, and the consent agenda, including the minutes of the March 4, 2024, regular meeting, was approved.

DISCUSSION/ INFORMATIONAL ITEMS:

Legislative Wrap-Up

In her President's report, President Watson shared a list of bills approved by the Governor and those vetoed directly related to the community colleges. She stated there were great outcomes for students, such as Wyoming's Tomorrow Scholarship Endowment funding and the kickstart money to fund the scholarships for the first year while the endowment builds. The endowment will be very useful for students and the College because it will provide student scholarships for non-credit programmatic areas. It is similar to the Hathaway scholarship but is for adult learners and has more flexibility.

President Watson stated that community colleges also received funding for inflation, which will provide slightly more operational money for things such as utilities. Local levies, however, are not expected to perform the same as in recent years, so there will likely be a decrease in funding received. Enrollment is expected to be slightly lower across the state and the nation because of lower graduation rates. While Northwest College gained money in some areas, there will be losses in others, resulting in a flat budget.

President Watson stated that the Governor vetoed one property tax bill and signed four others. Three signed bills are backfilled with State funds and won't affect the College's funding. However, one of the signed bills, which caps the rate at which property taxes increase, will eventually affect the funding in terms of growth. President Watson expects property taxes to be an interim topic.

The Governor also vetoed the repeal of gun-free zones. While President Watson is unsure if it will be an interim topic, she expects it will be a topic that will continue to be worked on. There were concerns about the legislation and whether it was specific enough or if it addressed areas of concern for the colleges. For instance, thirty-nine WY students in the residence halls are over twenty-one years old. The repeal of gun-free zones legislation would give those students a right to conceal, carry, and keep guns in their homes at any time, including while residing on campus. All residence halls currently have students who are over and under twenty-one. President Watson stated that the colleges are interested in more work being done to offer safeguards or local control and will be following the issue closely.

President Kuipers stated that she serves with Trustee Wurzel as Northwest College's representative to the Wyoming Community College Trustees (WACCT). WACCT is considering writing a letter of support for the Governor's veto of the repeal of the gun-free zones bill.

President Watson stated that the community colleges are not advocating any particular interim topics this year. The Community Colleges work closely with the Education Committee and will provide updates throughout the year, including during the interim.

State Fall Enrollment Report - Draft NWC

Lisa stated that the report will remain in draft form until the Commission approves it at its April meeting. Once approved, the full report will be available on the WCCC website.

Northwest College's final headcount for fall 2023 was 1,389 students, and FTE was 1,145. The report shows that while NWC's enrollment has declined over ten years, it is consistent with the enrollment trend of other state community colleges.

Since tracking began in 2000, Northwest College has had the highest percentage of full-time enrollment of all community colleges in Wyoming. However, in recent years, the part-time percentage has increased while the full-time percentage has decreased. Most College students take 3-5 credits (25%). The following highest percentage of students take 12-14 credits (22%) and 15-17 credits (20%).

The largest population of Northwest College's students is under 18, including dual and concurrent students. The next largest group is 18-19 years old, including some dual and concurrent students. The older age ranges trail off in percentages.

Most Northwest College students come from its service area (71%). NWC is tied with LCCC with the highest percentage of enrollment from states bordering Wyoming (10%), tied with three other colleges with enrollment from all different states (4%), and has the highest percentage of students from international countries (7%).

Northwest College students typically seek a transfer preparation AAS degree (37%) or are non-degree-seeking (41%), many of whom are dual or concurrent students. Fifteen percent seek only career/technical education, 5% seek multiple degrees across transfer and CTE areas, and 2% are in BAS programs.

Northwest College has the highest percentage of students enrolled in distance education (61%), the highest percentage of dual enrollment (21%), and the lowest percentage of concurrent enrollment (19%). Four percent of students take remedial classes, and four percent take co-requisite courses, which are developmental classes.

The community colleges' funding model is based on the level of instruction (LOI). Every course is assigned at the state level to a level based on its characteristics. Sixty percent of NWC's FTE is from Level 1 (lecture) courses, 27% from Level 2 (lab) courses, and 13% from Level 3 (high technology) courses. The high technology courses are described as having ancillary equipment used to teach them, such as in Welding and Nursing classes.

In response to a question from Trustee Kost, Interim Vice President Erickson stated that twenty courses are taught at Northwest College with the LOI 3 designation. These courses use a lot of technology, are very expensive, and are much more "hands-on" than other classes.

President Watson stated that the Facilities Committee has been working on an agreement with the City on the storm drain/retention basin project and is close to bringing it to the Board for approval. The President has been working with the City, and the document has had many revisions. The College wishes to ensure that some value will be received if it surrenders the land under an easement to the City for the project. The College had heard that the City has until October 1, 2024, to sign a contract with a vendor.

President Watson reiterated that the proposed project is not a retention pond but a retention basin that would hold water for a short period and defer the flow to the storm drain in the event of a major storm. The College would like to

make sure that the water table is accurately identified to ensure that the basin operates as intended when necessary and is otherwise an open grassy area that can still be utilized.

President Watson stated she has negotiated with the City to allow the College to connect the watershed of the Yellowstone, Lewis and Clark, and Simpson Hall fields and parking lots to the City's storm drain.

Trustee Housel stated that the Facilities Committee recognizes that the project is in the public's interest. The Committee addressed ambiguities in the original agreement to ensure nothing was left to chance, such as the high water table during irrigation season. The final detail to be worked out is that the agreement contains a provision identifying the exact location of the water table.

President Watson stated she had been working with a lawyer on how the water table relates to the basin's design. The Committee's feedback has been constructive in working with the City and its engineer. Once the water table has been established, the floor of the basin will be designed to be set one foot higher to allow flexibility if the water table fluctuates over time, serving the best interests of the College and its neighbors.

CITIZENS' OPEN FORUM

The Citizens' Open Forum convened at 5:00 p.m. No citizens requested to address the Board; therefore, the Citizen's Open Forum adjourned.

A UNFINISHED BUSINESS:

There were no unfinished business items on the agenda.

A NEW BUSINESS:

Major Maintenance Projects

President Watson stated the Major Maintenance project update is presented annually to inform the Board of upcoming projects and the status of those already underway.

President Watson clarified that the memo contains a duplication in FY2024 Major Maintenance projects. Line thirteen is to be stricken as it is the same project described in line eleven.

President Watson also noted that in FY2025, the Major Maintenance project, "Fire Detection Panel Upgrade Phase II," for \$65,000, should be added pending design and bid. Phase I of the project is listed in FY2024 projects. The existing panels are past their life expectancy, and replacement parts are difficult to find. The College will begin replacing the panels through a phased approach, prioritizing the areas of greatest need.

In response to a question from Trustee Housel, President Watson stated that the concrete repairs listed in the report refer to the slab that is north of the Student Center and the Cabre parking lot. While the sidewalks around the new building are included, this concrete is outside the project scope. The concrete was previously damaged by age and use and was identified to be replaced after the construction work. There will also be landscaping improvements made to that area.

A motion was made by Trustee Laursen and seconded by Trustee Kost to approve the Major Maintenance projects as presented. Motion carried.

State of Wyoming Matching Designation

President Watson stated that the legislation regarding the appropriated donor matching funds for community colleges requires the Board of Trustees to designate the purpose of the matching dollars. The Foundation requests that the Trustees designate the purpose to support the Student Center, scholarships, and campus programs.

In response to a question from Trustee Housel, President Watson stated that early discussions regarding using funds include using \$500,000 toward the Student Center, which would close out the Foundation's campaign.

Match dollars always appeal to donors as they can increase the impact of their contribution to their areas of interest. For example, a few years ago, the College eliminated soft-dollar athletic scholarships. The Foundation began a campaign to replace the soft-dollar amount with hard dollars, and a discussion was held with the President and Foundation Director about using some of the match funds to continue the endowment growth for student-athletes. Match funds may also support other endowments in areas of interest to donors. While discussions are ongoing regarding the use of the match funds, these areas have stood out as needing growth opportunities.

President Watson stated that the Foundation will receive the \$1 million designation upon submission of the board-approved Designation. The State and the WCCC must determine how to allocate the remaining \$1.3 million among the colleges. NWC and the Foundation stand ready to act on the \$1.3 million funds.

A motion was made by Trustee Todd and seconded by Trustee Housel to approve the State of Wyoming Matching Designation as presented. Motion carried.

President's Report

May 6, 2024

State

Legislature & Economic projections

No legislative meetings were held in April concerning topics related to the Community Colleges. Currently, no Interim Joint Education Committee meetings are scheduled until August.

The April CREG (Consensus Revenue Estimating Group) report, a key indicator of Wyoming's financial condition, was released on April 25, 2024. It brought good news, stating that our current revenue collections directed to the General Fund continued to exceed the pace by 32.3 million (2.2%). The Budget Reserve Account (BRA) is also trending positive, exceeding the forecast by 46.4 million (12.8 percent). The School Foundation Program (SFP) is also performing well, exceeding the forecast pace by 13.1 million (3.1 percent). While we observed declines in market prices for natural gas and coal, coal production, and recent trends in sales and use tax collections, these are expected to revert closer to the CREG forecast in the remaining months of the fiscal year. Dividends and Interest were 11.8% down in the permanent mineral fund, but capital gains were more than enough to cover any shortfall that might occur.

Sales and Use Tax collections are steady but relatively flat at 1.2 percent, and the Common School Account is up 1.4 million or 6.8 percent.

Governor

The State Building Commission met on April 10, 2024. The State Construction Division provided project updates to the Governor and Commission members. The updates included major maintenance and capital projects, with a special focus on the Student Center project.

Wyoming Community College Commission (WCCC)

The Wyoming Community College Commission (WCCC) meeting, held in Casper on April 18 and 19, was a productive one. The workshop discussion covered the Bachelor of Applied Science, Capital Construction projects, and Budgets. A workgroup was formed to discuss whether the rules should be changed to allow more BAS options at the Colleges. The Commission meeting centered on many business tasks such as the meeting schedule, commencement schedule, the strategic plan review, and the Directors' report. A new Commissioner was sworn in to replace Micah Wyatt, who stepped down.

Wyoming Association of Community College Trustees (WACCT)

The WACCT meeting was held in Casper on April 18 to coincide with the Commission meeting. Discussion was centered around post legislative support of the Governor. The role of the Trustees in WACCT and working with their respective Boards on legislative topics.

Wyoming Innovation Partnership (WIP)

The WIP received funding of 15 million from the legislative session. WIP III funding applications were being accepted until May 7, 2024, to extend or renew grants based on previous WIP initiatives. No new initiatives are to be accepted. Northwest College submitted renewals to continue efforts on Tourism, Software Development, and Virtual Reality. Grants will be reviewed and evaluated by the Governor's workgroup, and award letters will be announced in the near future.

Campus

The Faculty and Staff Recognition Luncheon was held on Thursday, April 11. It was a fun gathering with many employees celebrating service awards from 5 to over 50 years. Select employees were recognized as outstanding by their constituents. Char Klein, Dave Patterson, and Jo Ann Heimer were recognized. The International Student & Scholar Services team was recognized for the team award. The Faculty Distinguished Service Award was given to Anthony Polvere and the Distinguished Adjunct was awarded to Jessica Williams. David Austin received tenure and was promoted to Associate Professor.

The Juried Photo Student show was held on April 2, 2024. Student work was juried, and student winners were announced. The Juried Art and Design show was held on April 23, 2024. Student art was juried, and student awards were announced. Both shows reflected the creativity and quality of our NWC students.

The student Awards reception was held on Thursday, April 25, 2024. Outstanding students were recognized in each of the five academic divisions. It was a pleasure to speak and learn more about the students selected to win these awards.

The second annual Student Academic Showcase was held on Friday, April 26, 2024. I was thrilled to welcome everyone to campus and then stayed the entire day to attend all the sessions. Each session filled the conference center with conversations on poster presentations, visual showcases, and oral presentations. The University of Wyoming and the Program Director of Wyoming's Inclusive Excellence Team, Rachel Watson, once again attended with a group of UW grad students and staff. There were more people in attendance from the community and K-12 than last year, and once again, it was an amazing and uplifting day! I want to thank the entire Student Academic Showcase Committee, led by Dr. Amy McKinney, and everyone who worked tirelessly to create the event.

Strategic plan 2030

(Pillar 1.5.1) Hanover Research has been focused on the Community Needs Survey and the Regional Needs Assessment. The survey closed on April 30, and Hanover is currently processing the survey and working through the data. The regional needs assessment analysis is on hold pending budget, grant, and operational priorities. The report will be shared with the campus once finalized.

(Pillar 1.1.4.) The College learned the good news on April 12, that NWC was designated as an eligible institution under Title III. The designation allows us to apply for grants within Title III or Title V programs. We must renew annually but this opens up grant opportunities not otherwise possible to the College. My thanks to Lisa Smith and Mark Grant for preparing the documentation associated with the application and waivers. NWC and Ellucian Grant Services have also identified the TRIO grant as the first grant of focus and support from Ellucian.

(Pillar 4.1.2) Construction of the student center continues on schedule. Drywall, metal siding, concrete polishing and outside landscape work are the current areas of focus. The Soccer Fieldhouse design is

complete; the conversion contract is signed, and demolition of the drop ceiling has begun. The completion date is scheduled for the end of August.

(Pillar 4.3.2) The Institutional Effectiveness Committee met to complete the Support Service Program work for the year.

Powell Economic Partnership

I attended the PEP meeting on April 18, 2024, via Zoom. This two-hour quarterly meeting focused on planning and strategy. The values and mission of PEP were discussed along with the consent agenda and financials.

Forward Cody

I attended the Forward Cody meeting on April 23, 2024. James Klessens provided updates regarding the buildings and potential businesses showing interest in growth and relocation. Additional time was spent on the financials and planning work for the shooting complex.

Foundation and Alumni

The Foundation Board met on April 24, 2024. I had the pleasure of attending and later participating in the joint Foundation, Alumni and Board of Trustees reception.

Northwest College Board of Trustees Report May 1, 2024

Finance & Budget

- The Northwest College Building Authority Board of Trustees, composed of Mark Westerhold and Dave Gilliatt, convened on April 3rd, 2024. The board was able to appoint a new Trustee, Dusty Spomer. The Board then appointed new officers: Dave Gilliatt as Board President and Dusty Spomer as Secretary/Treasurer. The Board then accepted the resignation of long-serving Board member Mark Westerhold and thanked him for his service. Northwest College currently utilizes the Building Authority to pay the bond related to Simpson Hall. No other projects will need to use the Building Authority's services in the next year or two.
- Pursuant to the memorandum that the Foundation presented to the College Board of Trustees in the April meeting, our College President, Foundation Executive Director, and Finance Director worked with the State Treasurer's office to apply for the matching funds that were appropriated in this past legislative session. The Foundation donated 2.3 million to the College, and the state matched 1.6 million. These funds will be allocated to the new Student Center, scholarships, and campus programs.
- The College President and Finance Director have met with all the Budget Managers and discussed known and potential revenue streams. Overall, state funding is up, the local mil levy is down, and enrollment is primarily flat, giving an overall consistent revenue projection for 2024-2025. The Finance Director has been meeting with several departments across campus and has gathered various needs and adjustments to consider when developing the detailed college budget in the upcoming month.
- The Grants Leadership Team has selected the TRIO Student Success Services Grant as the first of nine grants for Ellucian to help the college develop and write. The RFP opened on May 1 and will close on July 15. The Grants Leadership Team has been pleased with the work and cooperation that Ellucian has provided.
- The Business Office has updated any relevant course fees approved by the Board in December, including fees for student accident insurance, housing rate adjustments, and meal plan rate adjustments. Billing has been turned on for the summer semester.
- The Business Office has been working with several students during early registration and establishing payment plans to help students with significant balances prepare for registration in the fall. The Business Office has also been working with the Registrar's Office, the international office, and others to discuss options for students.
- The Business Office has celebrated the retirement and achievements of Jo Ann Heimer, who has faithfully served the College for over 50 Years. Her institutional knowledge will be missed. Over the past 12 months, she has trained newly hired staff and left the College in capable hands. Jo Ann plans to take it easy for six months before starting the next chapter in her life. We wish her well in her future endeavors.

 members about job opportunities at NWC and careers in higher education.
- Training: Employees are completing the annual EEO and Title IX compliance training. The HR
 Director attended a webinar by the law firm Littler Mendelsohn on 4/26/2024, "DOL Announces
 New FLSA Overtime Salary Threshold. Are You Ready?" for more information.
- Performance Evaluations: The HR Director distributed the FY24 Staff Performance Evaluation form on 4/15. Staff who are off for the summer will have their annual review completed in May. Year-round staff will have their reviews in July, allowing time for the fiscal year to be completed on 6/30 and provide a comprehensive review of the year.
- Legal Compliance: The new Title IX regulations were released on 4/19. The Title IX Coordinator and Policy Review Specialist, Laura Gwinn, met with the HR Director to discuss preliminary recommendations and policy updates. - The updated salary thresholds for overtime exemption were released on 4/23. The Department
 of Labor (Department) has updated and revised the regulations issued under the Fair Labor
 Standards Act regarding exemptions from minimum wage and overtime pay requirements for
 exempt (salaried) employees.

• The HR Director, Finance Director, and President have been anticipating these FLSA salary threshold changes and identifying potential plans for NWC compliance. The College has options such as reclassifying those affected employees with salaries below the threshold as nonexempt (hourly), adjusting affected salaries to meet the thresholds required to maintain exemption from overtime if funds are available, and/or increasing their assignment periods. There are two effective dates for implementation with different levels of salary requirements, 7/1/24 and 1/1/25, so the College may choose to stagger its changes accordingly. Agriculture (Ag)

On April 1st NWC hosted one in a series of seminars around the state as part of the new UW Ranch Management and Agricultural Leadership program. We had several students and faculty attend. The seminar was focused on getting young people involved in agriculture operations and building strong agricultural leaders.

Business

Business faculty hosted the last Entrepreneur Bootcamp/Workshop at NWC on Thursday, April 18 from noon-4:30pm. We had 31 registrants (with a few no-shows) and another 10 subject matter experts/successful entrepreneurs in attendance. All of the feedback from attendees was extremely positive. They really found value in this alternative format, where we replaced formal presentations with more time for attendees to visit one-on-one with SMEs and successful entrepreneurs. Discussions involved the following: digital/social media marketing, branding, sales, operations/supply chain, financing/small business loans, accounting, legal, successful entrepreneurs' experiences, and many more. Our EDA grant funded through UW-IMPACT 307 will shortly expire. However, another great outcome of this workshop was the fact that attendees were able to network with these area resources; therefore, attendees now know who to reach out to in the future for additional help with their startup businesses.

Stacy Kuenn continued Trappernomics for Southside 5th graders. One of the NWC students volunteered throughout, giving a 20-year-old perspective (which is the scenario we give the students in Budgeting and Banking activities). The feedback is positive so far. We are currently doing our 3rd and last group presentations at Southside.

Kevin and Stacy Kuenn also volunteered with Southside 4th graders as the students were "enlisted" into WYTOPP Math Boot Camp. The students completed math problems as they completed obstacle courses to help prepare their minds and bodies for excellence! They acted as mentors, coaches, and tutors. Stacy Kuenn attended and networked with Small Businesses and supporting organizations (WYSBC and PEP) with community events such as Café 307's succession planning meeting, meeting with Devan Cherie Costa-Cargill and Rebekah Burns to investigate resources for students and small businesses, and meeting with Pardner's Café to discuss potential opportunities for community outreach by students. Stacy Kuenn assisted the photography department with interviews of their upcoming graduates.

The Global Studies Seminar featured two sessions for faculty and staff on creating, expanding, and implementing collaborative and trans-disciplinary faculty-led study abroad (7 people attended), a lunch talk featuring global peacebuilder and educator Aziz Abu Sara (31 people attended), a panel discussion on international students' perspectives on cultural exchange and academic adaptation (36 people attended), and a talk by Sybil Tubs, Education Manager at the Heart Mountain WY Foundation, titled "The Fear of Foreigners: A Look at Xenophobia in America" (24 people attended).
- David Austin, Assistant Professor of Psychology, was awarded one of six \$6,000 Undergraduate International Studies and Foreign Languages (UISFL) Course Development Faculty Grants for year one of the UISFL Grant. These \$6,000 grants are to be used to support the design of new courses or the redesign of existing courses to include demonstrable, measurable Global Studies Learning Outcomes. Austin plans to travel to Portugal this May.
- Jo-el Sauers, Fixed Term Instructor of Education, was awarded one of seven \$3,000 UISFL Program Development Grants for year one of the UISFL Grant. These Program Development Grants are awarded to academic and non-academic programs to further the international engagement of their programs, offices, centers, or units. Sauers will use this grant to organize an International Literacy Family Night in Powell in the fall and build an international library in the NWC Education Department of Children's Books that promote culturally responsive teaching.
- Hosted recruitment webinars for the following agents:

 - o College Dream Honduras (5 students and their parents attended)

PEER TUTORING SERVICE

HINCKLEY LIBRARY

- We welcome Susan Adkins Library Coordinator to our team!
- This semester we taught 14 library instruction classes to 240 students and have continued hosting the monthly Stothart Readings.
- During the District Music festival in April, we welcomed the NWC choirs to rehearse in the amphitheater and provided a safe space for the high school students performing on campus. We also welcomed all the FFA students who came to Northwest for the judging competition.
- The library was able to display several art exhibits, including wire sculptures, skateboard graphics, Graphic art heroes, and ceramics from around the world.

- Along with the other Wyoming community college libraries, ours was awarded a grant to house a set of 25 virtual reality goggles and charging stations for our students to use in upcoming classes. Faith will be going down to Laramie in May for training.
- In April we hosted the Wyoming Connections Academy for their WYTOPP state standards testing.
- We saw a dramatic increase in library usage this semester. Our database usage is already up by 1000 searches over last year, and our gate count is 5000 higher than last fall!

- The Office attended the Wyoming Association of Student Financial Aid Administrators/WYASFAA conference in Casper, WY
- The Office continues its search for qualified applicants to fill staff vacancies

GEAR UP

- NWC GEAR UP is currently serving 272 students of the 225 minimum that is required
- For Objective #1 we are required to serve 225 students and we currently have 272 students. Out of the 272, 244 have had some service es (which puts us at 108% for Objective #1). Students with an hour or more of service we are sitting at 98.6%
- For Objective #6 we are required to get 60% of our seniors to complete the FAFSA and we are sitting at 67% and still working to complete more. We will continue throughout the summer to assist those students on completing their FAFSA and enrolling in post secondary education
- For Objective #9 we are required to get 45% of parents of GUWY students who receive services for at least one year will participate in activities associated with assisting students in understanding and/or obtaining scholarships and/or financial aid for college. We are currently sitting at 72% and plan to get higher before the end of the grant year
- We have 9 spots for Summer Academy and possibly going to get a few more. We currently have 12 students that have turned in applications to attend
- The current grant cycle will end this year and the University of Wyoming has submitted a new grant application for another 7 years
- I was informed that our GEAR UP College Freshman that are also in the TRIO program are saying that they understand the FAFSA vs. non-GEAR UP students. The work we are doing with our students is working

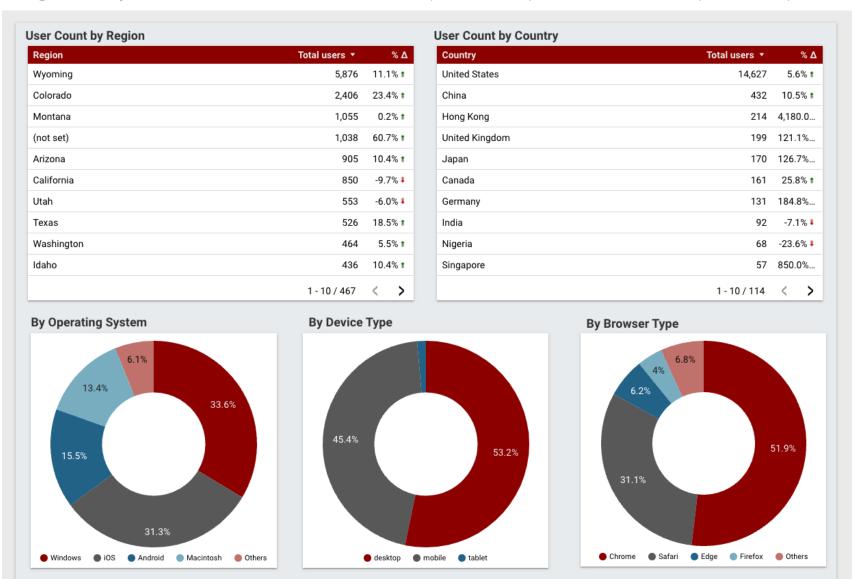

Temporary Dining Facility -Soccer Fieldhouse

The design work for the Fieldhouse is complete. Groathouse Construction has begun dismantling the drop ceiling, reviewing plans, ordering materials, and marking the concrete for wall placement. Current estimates put the completion of the fieldhouse in late August, assuming all materials arrive promptly.

Student Center Building

The construction of the Student Center Building is progressing impressively, with the installation of the metal panel siding nearing completion. Earthwork is in full swing to clean up the construction site, and concrete and landscaping will be the focus for the near future on the outside. The hanging of drywall inside the building is almost complete, and concrete floors are being polished along with ongoing texturing, plumbing, and electrical work. The project's steady pace continues to bring a sense of reassurance and excitement to campus.

The Foundation will host a Hard Hat Tour on June 4th for the Presidential Partner donors to tour the Student Center.

Project Financing

With generous donations from the foundation and matching funds from the state, Northwest College has sufficient funding for the rest of the student center and soccer fieldhouse conversion. The College is scheduled to pay the remaining 2.6 million to the State of Wyoming over the next few months as we wrap up the project.

Comments

Food Service- Northwest College budgeted 275 meal plans for Fall 2023 and 265 for Spring 2024. As of August 29, 2023, Northwest College had sold 320 meal plans for Fall 2023 and 275 meals for the spring. Food service continues to operate on a modified contract with Sodexo under a cost model with a capped management fee of \$10,000. Northwest College continues to work with Sodexo's management to provide our students with the best food service product at a cost within budget. Additional costs (transportation, compostables) have been incurred as part of the Student Center project and will continue until the project is complete.

Residence Halls- Northwest College budgeted 275 students to live in the residence halls for Fall 2023 and 265 for Spring 2024. Occupancy for Fall 2023 and Spring 2024 was divided between Simpson, Lewis and Clark, and Colter Halls. As of September 8, 2023, Northwest College's Fall 2023 occupancy was 315 students and as of February 22, 2024, Northwest College's Spring 2024 occupancy was 269 students.

Copy Center and Motor Pool- Revenue for the copy center (print services) and motor pool are recorded the month following when services are performed. Management is reviewing internal charge rates for Motor Pool and the Copy Center. Internal Rate changes will be considered and implemented for fiscal year 2024-2025.

CONTRACT FOR SERVICES

THIS AGREEMENT is made and entered into by and between PARK COUNTY SCHOOL DISTRICT NO. 1 BOARD OF COOPERATIVE EDUCATIONAL SERVICES, (hereinafter "BOCES"), and NORTHWEST COMMUNITY COLLEGE DISTRICT, d/b/a NORTHWEST COLLEGE (hereinafter "NWC").

In consideration of the services to be provided by NWC as set forth below, BOCES agrees to pay to NWC \$100,000.00. BOCES agrees to pay NWC funds at least twice a year- with half paid by January 30th and half paid by June 30th. The NWC management fee shall not exceed 8%.

For and in consideration of the payment by BOCES to NWC as referenced above, NWC agrees to provide the following services and/or facilities and equipment to facilitate providing community educational services through BOCES:

- 1. Provide personnel, such as a Workforce Coordinator and/or a Community Education Specialist to operate the community education program. NWC personnel shall assist in coordinating meetings of BOCES, sending out notices, taking minutes, and otherwise assist in operating the day-to-day activities of the BOCES. NWC shall be solely responsible for employing these individuals and for all payroll costs, expenses and/or benefits associated with individuals employed by Northwest College to assist BOCES.
- 2. Manage the funds paid to NWC from BOCES as reasonably appropriate so as to utilize as much of the funds as possible for programming (materials, books, instructors, advertising, etc.). These funds shall be utilized to operate the community education programs, including the costs of instructors, travel, supplies, as well as direct and any indirect costs or expenses.
- The receipt and expenditure of funds paid by BOCES to NWC shall be accounted for and managed by the NWC Business Office. NWC shall annually provide an accounting to BOCES of the expenditures of the contracted amount paid to NWC and shall also provide such other information relative to that funding as may be requested by BOCES.
- 4. Assist the BOCES Board in creating an annual budget.
- 5. Provide facilities, together with all infrastructure (furniture, phone, technology, etc.) to house the BOCES program and personnel provided by NWC to operate the program and to pay all overhead, costs and expenses associated with such facility/office.
- 6. Develop partnerships with other community education providers in the Park County School District #1 service area.
- 7. Facilitate an annual planning process with the BOCES Board to develop strategic initiatives with programming goals and parameters.
- 8. Contract with facilitators/instructors as necessary for the community education programs.

- 9. Prepare specialized advertising for community education classes.
- 10. Recruit students.
- 11. Reserve and/or schedule, as necessary, facilities and/or rooms in which to conduct the community education classes.
- 12. Manage registrations and determine fees for such classes.
- 13. Evaluate community education programs and provide information regarding the community education offerings to the BOCES Board quarterly.
- 14. Continually strive to improve and increase program offerings based on the anticipated needs of the community. Increase in programming will be evaluated by the BOCES Board and supported by an operational funds increase if necessary.

BOCES and NWC agree to annually review with each other the services requested by BOCES and those being provided by NWC. It is anticipated that this review should occur at or about the time the BOCES budget is being developed.

This agreement may be terminated by either party giving to the other party not less than ninety (90) days written notice of the intent to terminate this Contract. Unless terminated, this Contract shall be renewed annually beginning July 1st of each fiscal year, subject to the terms and conditions set forth herein.

This Contract may be amended by a written amendment approved by both parties to the Contract.

Northwest College FY202 Budget Overview

FY2025 Budget Message

Northwest College, in its commitment to a student-centered mission and high-quality educational programs, crafted the 2030 Strategic Plan in Spring 2022. This plan, a culmination of recent transformative exercises and the College's rich history, sets the course for the campus and community service in the years ahead. The vision statement, "Destination and Destination of Place," guides our future endeavors and upholds our mission.

FY2025 marks the start of the biennium budget for State appropriations. The initial allocation model was based on weighted credit hours from FY2020 and FY2021, completed weighted credit hours from FY2021, and weighted degrees and certificates from FY2021. However, the final model will use 2023 academic completed degrees and certificates. Northwest College anticipates a slight decrease in its funding allocation model, from approximately 11% to 10.75%. The 2024 Wyoming Legislative Session approved \$ 16,050,021 for the Wyoming Community Colleges (CC) for inflationary funding for the 2025-26 biennium. This funding, allocated through the fixed cost formula, is projected to increase Northwest College's funding by approximately \$800,000 for FY2025. Considering the decrease in the funding allocation model and the overall increase in allocated funding, Northwest College's overall increase is estimated to be about \$450,000 for fiscal year 2025.

The 2024 legislative session allocated an additional \$1,187,455 to the CCs for compensation, including taxes and benefits, for the FY2026 fiscal year of the biennium. Northwest College appreciates this funding, which is crucial for supporting operations and staffing. We will continue to advocate for additional compensation and inflationary cost increases whenever possible.

As a reminder, based on the 2023 legislative session, the level of instruction for completed credit hours will be updated to increase the value of online instruction courses from 80% to 100% within the weighted credit hour calculation. This change in definition is effective July 1, 2023, and will be used for the 2023-24 academic year. Therefore, the funding allocation model will not be affected until FY2026, when the 2024 academic year data is utilized. Based on current estimates, this definition change will have minimal impact on Northwest College.

During the 2021 Wyoming Legislature, a new statute modified how oil and gas companies would pay mineral taxes. This legislation removed the 18-month delayed payment between production and when taxes are due. This change increases mineral revenue in years of high production but also reduces revenue and removes the 18-month delay in years of reduced production. In 2022, mineral and gas companies could elect to defer payments from the 2021 gas production over the next 13

years. Many companies elected to pay the 2021 gas production taxes and paid the 2022 production taxes. Few companies took the deferral.

For Park County, mineral taxes represent approximately 35% of the assessed valuation. According to the January 2024 Wyoming CREG (Consensus Revenue Estimating Group) report, production and forecasted prices for oil are estimated to remain consistent for FY2025. The CREG report also estimates a reduction in the production of Natural Gas but an increase in the forecasted price per production. Northwest College forecasts consistent mineral tax cash collections for FY 2025. County assessments for property taxes have been at all-time highs for the past few years. Current assessment estimations for Calendar year 2023, to be collected in fiscal year 2024-25, are lower than previous years.

For adult (non-traditional) learners, the Big Horn Basin unemployment rates have remained steady over the last few years. For traditional learners, the May 2023 high school graduating class was the largest in recent years. The May 2024 class is also projected to be one of the largest classes in recent years but smaller than in 2023. This could result in a slight decrease in enrollment for Fall 2024. Northwest College will remain conservative on its enrollment for FY 2025. In addition, the Wyoming Community College Commission did not raise tuition rates or modify the tuition structure for FY 2025.

As of April 29, the College is projecting the following FY2025 Operating Fund (Funds 10, 14, 15) and One Mill Fund (Fund 11) revenue budgets. Local appropriation increases assume that other CC service district levies will also increase at rates comparable to Park County's.

Revenue sources

State Appropriation: Northwest College receives approximately 56% of its operating revenue from the State of Wyoming general fund appropriations. As noted above, Northwest College's percentage of the funding allocation is estimated to be consistent between FY2024 and FY2025. Estimated revenue has remained consistent due to the influx of funding by the 2024 Wyoming State Legislature. The table below provides an overview of funding allocation model components.

Additionally, Northwest College continues to budget conservatively regarding local appropriations in the state allocation model by excluding estimates from recapture/redistribution. Northwest College conducted an inquiry of other Wyoming Colleges, and at this time, the impact of production year 2023 valuations and fiscal year 2024 local revenue is unknown.

Local Appropriations: Northwest College works directly with the Park County Assessor's Office in estimating county valuation and local tax levy revenue. Local valuations are not final until June 2024, but mineral valuations in Park County are projected to decrease due to current production and prices. Mineral revenue is based on 100% of the assessed production valuation, while residential property values are based on 9.5% of the assessed value. Residential and commercial property valuations continue to increase, but these revenues will never offset a decrease in mineral revenue based on the assessed percentage. Park County expects the valuation split between mineral revenue and property valuation to remain at 35%/65% compared to the 65%/35% funding ratio prior to 2017. The decreased mineral valuation is projected to decrease the overall valuation from ~\$1,075,000,000 to \$999,750,000, or approximately 7%. Northwest College is budgeting local revenue conservatively at 90% due to recapture/redistribution and mineral valuations. The local appropriation increase on residential and commercial property will not be final until June 2024. Mineral royalties from the oil and gas companies will not be known until production occurs. This requires close monitoring of oil and gas prices and increases Northwest College's budget risk.

Enrollment/Tuition: National experts and the College continue to monitor enrollments for FY2025. Longitudinal enrollment data suggest traditional-age enrollment is expected to decrease in Fall 2024 due to smaller May 2024 high school graduating classes compared to May 2023 classes. Early registration began on April 18, but it is too early to estimate Fall 2024 enrollment.

In September 2020, the Wyoming Community College Commission approved increases to Fall 2021 tuition rates and removed the tuition cap. In September 2023, the Commission voted to keep tuition rates flat for FY2025. In-state tuition is \$105, WUE is \$158, and out-of-state tuition is \$315 per credit hour.

Fees: Northwest College's fees include two categories: student mandatory fees and student course fees. Mandatory fees apply to all credit hours at Northwest College, and student course fees apply to specific courses. Student Mandatory Fees: Student mandatory fees were \$53 per credit hour with no cap on fees for FY2024. The Board of Trustees voted not to change mandatory student fees for FY2025.

Student Course Fees: Student course fees for FY2025 will only be increased if a program determines that increased costs are needed to maintain or enhance a student's experience.

Other Sources—Northwest College expects revenue from other sources to remain consistent for FY2025. No significant changes are expected regarding interest revenue, music festival/camp attendance, or grants. At this point, Carryover amounts have not been identified.

Campus Efforts Associated with Budget Stabilization

Northwest College continued a process of shared governance during FY2024. Institutional efforts have focused on institutional stabilization and strategic planning. The following activities are utilized to keep open lines of communication, shared governance, and to advance the College.

Academic Advisory Council (AAC)- This committee continues to review and determine acceptable criteria for evaluating academic programs. This committee outlined the following criteria as part of its practice when evaluating existing and new educational programs:

- 1. Cost vs. tuition and fee revenue
- 2. Credit hour production per full-time faculty
- 3. Number of declared majors vs. the number of faculty
- 4. Number of degree completers vs. the number of majors
- 5. Program content in the context of the overall curriculum is content essential to support other programs
- 6. Essentiality of content to general education requirements
- 7. Job market or demand for program graduates
- 8. Qualitative considerations importance to the community, etc.

Budget Managers—Budget managers continue to play a role in the sustainability of the College's budget. In FY2024, they were asked to operate conservatively as part of the focus on funding the new Student Center project. The request has been for budget managers to purchase and travel as necessary for their programs but not to buy excess inventory or items that are not considered essential. Budget managers continue to work with their respective VP's and the Business office.

Institutional Effectiveness Committee (IEC)- This campus committee continues to support and review support service programs and advise on budgetary ideas (reductions or increases). IEC met in FY2024 to support 2030 strategic planning and perform support service program reviews.

President/Vice Presidents/President Staff - Northwest College's President, Vice Presidents, and President Staff met regularly to discuss the College's operations. Any needs or ideas generated in this group were discussed and analyzed to determine feasibility. In addition, the Vice Presidents approved FY2024 expenditures above \$250 to increase knowledge regarding spending by area.

2030 Strategic Plan - FY2024 focused on key strategic efforts identified in the President's Operational Plan. Capacity continued to be challenging with lean employee budgets and time committed to finding qualified applicants for open positions.

Welcome to Wyoming Scholarship- The Welcome to Wyoming Scholarship was a charge from President Watson and a combined effort between the intercultural program, athletics, financial aid, enrollment services, business office, President's office, and the Foundation. This Scholarship seeks to enhance Northwest College's financial affordability for national and international students and improve Northwest College's ability to recruit students from the highest-cost tuition category, the out-of-state rate. Besides increasing enrollment, housing, and dining usage, the idea is to increase Northwest College's campus diversity with students driven to complete their degree or certificate at Northwest College. The estimated cost of this soft dollar scholarship for FY2025 is \$350,000 to \$400,000. Over 100 Out-of-State students were on campus in fY2024.

Budgetary Work to Occur in May

- 1) Compensation—No funds were allocated to compensation for FY2025. Fair Labor Standards Act changes are under review for upcoming regulatory changes. The Human Resources Director will continue reviewing compensation in FY2025 to plan for FY2026.
- 2) Review of Open and Interim Positions—The President and Vice Presidents continue to review open and interim positions. Hiring decisions will be made, and corresponding budget adjustments will occur as usual.
- 3) Revenue Lines Reviewed—A final review of revenue lines will occur. Budget lines will be adjusted based on the latest information gathered regarding state funding allocation, local levy estimates, enrollment trends, and analysis of other revenue sources.
- 4) Expenditure Lines Reviewed—A thorough review of expenditure lines is ongoing. Lines are under review and will be adjusted based on contractual or inflationary adjustments. Reductions may be made if operational changes warrant reducing the budget.

Remaining Shortfall

If a budget shortfall remains after the budgetary work in May is performed, the College may request the Board approve the use of reserves or one-time-only funds for fiscal 2025. This utilization will allow the College to continue to monitor legislative funding, Statewide local levy valuations, and enrollment trends and perform additional assessments of service and academic programs. No changes will be made without analysis and communication as required in College Policies.

Other Operating Funds

One Mill Fund (11)

Due to the interrelated expenditures and department lines in both areas, the One Mill fund budget work has occurred in tandem with Fund 10. As noted above, One Mill revenue is projected to decrease and is not subject to recapture/redistribution.

Auxiliary Fund (12)

The Trustees approved housing and meal plans at the February 2024 Board meeting. Rates were approved based on the ability to operate programs with 300 students in the fall and 275 students in the spring. All other auxiliary departments are being reviewed and budgeted to ensure they operate at break-even levels.

Restricted/Grant Funds

The grant administrators and the business office are developing budgets related to restricted or grant funds. The budgets are expected to be similar to FY2024.

Plant Fund

Primary revenue sources are from the State of Wyoming for major maintenance, mandatory student fees, and student usage fees from residence life. Budgets for major maintenance are expected to be consistent with FY 2024 receipts of ~\$1.3M.

Summary

The President will monitor Federal and State legislation, local mill levy valuations, and enrollment trends and will work with the Vice Presidents, budget managers, Finance Director, and college employees to finalize the Campus budget over the next two months. Any major changes will be made in consultation with the Board Finance Committee.
